SHORT SKETCH OF THE BACKGROUND OF THE TOWN OF CLIFTON

The present Corporation of Clifton, Virginia, is situated on land owned originally by William Beckwith, well known freeholder of the Federal period. At his death most of this estate was will to his many slaves, and through sale part of it came into the hands of the Otis and Hetzel families, of New York and Louisiana respectively; the remainder was long held by the Harris family, colored, legatees of Billy Beckwith.

The oldest remaining building in this vicinity is said to be a part of the present home of Mrs. Clara Tumor, colored, on Church Street, which was one of the log dwellings on the Harris property. Two other very old buildings still remain in a portion of the house on School Street owned by Mrs. Iona Koontz, which was once a school, and part of the rebuilt Clifton Hotel, north of the Southern Railroad tracks on the Centreville Road.

It was in the 1880's that Harrison Otis built this hotel, which he contemplated called "Devereau", but later decided to call "Clifton" after his native town in New York State. The Clifton Hotel became a popular and fashionable resort for New Yorkers, and later gave its name to the settlement which grew up in the vicinity.

Both congregations now active in the town were established during the 1870's, the Clifton Presbyterian Church being built on the slope northwest of the railroad, and the CliftonBaptist Church being built on Main Street on land donated by George Tillet (the present building was rebuilt on the same sight).

Acasia Masonic Lodge, chartered in 1877, is the second oldest lodge in the county, having been organized during the period of Masonic expansion after he Civil War, following the Henry lodge of Fairfax (founded 1868):

When the town became a station on the Southern Railroad and the post office was moved there from its old location at Union Mills, the town expanded gradually. In 1902, at the suggestion of Commonwealth Attorney Vernon Ford, leading businessmen applied for a charter of incorporation from the state, and the first Council meeting was held April 7 of that year. Mayor R. R. Buckley presided, and councilmen M. M. Payne, A. JJ Kidwell, J. B. Cross (father of the present mayor), and Lewis Quigg, were sworn into office by Justice of the Peace A. W. Robinson. R. M. Kivett and W. H. Mathers were elected Town Sergeants and sworn into office, also.

Among the licensed businesses appearing on the first assessment list are: R. M. Kivett, Butcher; J. L. Fristoe, General Merchandise; S. H. Detwiler, Livery; M. M. Payne, General Merchandise; Southern Railway Express; Western Union Telegraph Co.; F. G. Mayhugh, Bar; and Buckley Brothers, General Merchandise.

The year of 1903 was started off with a bang by the building of a new lockup, costing \$12.75--a far cry from the new Council Hall now in use for official business--which had the misfortune to be burnt down onedark night by a lady tramp. During this same year the Council apointed a committee to stake off land for a school and estimate operating expenses. This first school in the Corporation was situated on the lot next to the present resident of the Elgins on Main Street. It continued to house the grammar school and two years of high school until the present school was erected in 1915 on the hill north of the Railroad.

In March 1938 the Virginia General Assembly reapproved the charter of the Town of Clifton, establishing the present system of government with a mayor and five councilmen elected bennially, and Town Sergeant and other necessary officials appointed by the mayor and council.

After discussion of the various details involved in enforcement by the county, it was decided to delay action until the July meeting in order that copy of the ordinance might be posted in the corporation. Mr. Sagendorf was also asked to inquire of the Commonwealth Attorney, Mr. Marsh, whether it is necessary to advertize such an ordinance before approval by the Town Council.

There being no further business to come before the meeting, it was adjourned at 9:30 p.m.
