Councilman Detwiler presented request from the Clifton Volunteer Fire Department for installation of 80 feet of 12 ft drainage pipe in front of the Fire Department lot on Chapel Street, to be laid as directed by the Street Commissioner. Made in form of motion, seconded and carried. It was decided that Mr. Phillips should look at ditches near Mrs.DW. Buckley's to tell what should be done to carry off the overflow water. Chapter 507, Legislature of 1948, that the State Secondary Highway System may include up to two (2) miles of streets for maintenance, improvement, construction and reconstruction; which after July 1, 1948, may be increased annually up to a maximum of one-quarter (1/4) mile, at the request and recommendation of the governing body of such towns under 3500 population:

It is hereby resolved, that the Town Council of Clifton, Virginia, shall recommend and request that the State Highway Commission include in the Secondary Road System the following described streets having a 30-foot usable right of way.

- 1. Dell Avenue from intersection with Main Street to end of street 1/8 mile Condition: 10 ft gravel surface treated

 street 1/8 mile
 Condition: 10 ft dirt.gravel 200 ft from Main St.

The Town of Clifton certifies and guarantees to the State Highway Commission that the right of way widths as above described for each section of road elist, or will be provided by the Town at no cost to the Highway Commission before said street, or streets, are taken into the Secondary System.
