The mayor reported that speed signs for the Clifton streets would be manufactured in Culpepper, and would therefore be delayed somewhat. The State Police Troopers have been in Clifton several times and will continue to come until the speeding is under control.

The mayor reported that the installation of piping for drainage in front of the Clifton Hotel had been delayed because it had not been possible as yet to get in touch with Kenyon Mathers, part owner of the property.

Consideration was given to the matter of opening bids for trash collections, to be awarded in two weeks if possible. It was suggested that this bid should be on the basis of 8 collections a year (extra collections on months of July and January). It was then moved and seconded that the clerk be authorized to make arrangements for bids for trash collection on a yearly basis, on the basis of 6 collections per year, with the understanding that if additional collections were needed, additional compensation would be made at the same rate. Motion carried.

Mr. Buckley reviewed the efforts to secure primary road from Manassas to Fairfax Station since inception of the idea of the Monticello Highway Committee. The committee is now trying to safeguard rights-of way on the preferred route. After some disucssion it was moved and seconded that a resolution be adopted that the Fairfax County Board of Supervisors take such action as necessary to incorporate into the county road system approximately 1 1/2 miles of road from Johnny Moore to Bull Run and that section between the James Johnson property and the Maniply property; and to authorize appropriate authorities to execute such necessary papers to secure rights-of-way. Motion carried.

It was reported that sidewalks are badly in need of repair between Pete Fullerton property and thefBaptist Church, also in front of Paul Longerbeam's. The mayor will check on wheather there is still a portion of the money deposited in the Clifton account with the State Highway Department which has not been expended.

Mr. Buckley reported that he had heard that Mr. Ralph had found the starting point and was working on the town survey. The mayor reported hat he had given a map and copy of the charter to Mr. Ralph.

The mayor reported trouble with sleighriders on the hill near Mrs. Buckley's. Quiet Zone signs were posted there and at the Cross property (due to Mrs. Lyddell's illness).

The Mayor noted that Mr. Padgett had disposed of about 13 dogs since the new dog control ordinance was passed, but that a child had been bitten yesterday by a dog owned by man living on the Jim Robinson place (not within corporate limits).

After some discussion relative to criticism evoked by bid procedure followed on trash collection, it was moved and seconded that sealed bids be requested for the removal of all trash in the Town of Clifton for the period of one year, with a minimum of 12 monthly collections on the last Saturday of the month, starting with the month of April 1954; such trash to be placed in containers along the public right-of-way; any postponement due to inclement weather, and the page of disposal, will be arranged by mutual agreement between the contractor and the mayor of the Town of Clifton; bids are to be addressed to the mayor of Clifton on or before 8 p.m. 6 April 1954. Motion carried.

(It was moved and seconded that this trash collection be paid at the previous rate when trash at McIntyre property has been picked up. Motion carried.)

The mayor reported that speed signs have been put up, and that Mr. Aimols is having his books check to ascertain whether there is a credit balance to the Town of Clifton for construction of sidewalks.

The matter of street signs was reopened, and clerk was instructed to contact the company previously dealt with to ascertain present prices and availability, and to report to next regular council meeting.

Mayor reported Mr. Padgett had secured 3 or 4 dogs recently and had disposed of 1 or 2, but that more were roaming the vicinity.

Mr. Buckley noted that it was his understanding that corporation residents would not have to purchase the new Fairfax County automobile license plate. The mayor reported that Mr. Hugh Marsh had been contacted for a final ruling on this matter.

Mr. Buckley reported that the clerk had forwarded to the Fairfax Board of Supervisors a copy of the resolution favoring right-of-way protection of the Manassas-Fairfax Station route via Ivakketa Road from Johnny Moore to Maniply's.

Clerk read a letter from Mr. J. H. Gunther to the mayor asking that zoning protection be invoked to prevent such business as wrecking garages from marring residential sections of Clifton. After some

discussion, it was moved and seconded that the clerk resubmit to the Circuit Judge Paul Brown the names of the proposed Zoning Commission for the Town of Clifton. Oral submission of these names was made some years ago, but no further action was taken to appoint the Commission.

Clerk read a letter from Mr. J. G. Kincheloe requesting the Town Council to send to the State Highway Department in Richmond a resolution favoring the improvement of the Yates Ford Road from Manassas to route 645 near Bull Run. After thorough discussion, it was moved and seconded that the clerk acknowledge Mr. Kincheloe's letter and inform him that although this is an interesting proposal, the Town Council has already sponsored a route from Manassas to Clifton via the Ivakota route.

Treasurer reported that four tax bills have been delinquent approximately 4 years, but that the rest of the accounts are in good shape.

It was suggested that the clerk write a form letter suitable to be sent to any of these delinquent accounts, informing that if the bill is not paid it will be turned over to the town attorney for collection.

The matter of June 1954 election was brought up and the clerk will post excerpt of instructions and circulate to homes as in previous years.

Mr. Buckley reported that Community R coreation Committee has been considering possible improvement of the park site, and finds that wood on the property could be cut and sold; the committee would like to have permission to have the site burned over, leveled by bulladzer, and wood sold (except such large trees to be retained for shade and such cut tree trunks as might be used to build a Bootbridge across Pope's Head. Present members of this committee are Mrs. Elva Ambler, Mrs. Josephine Bryce, Mr. Pat Clifford, and Mr. James Johnson. Mr. Detwiler noted that Mr. Bryce would furnish chain saw when needed. It was moved and seconded that Mr. Buckley be given authority to clear and improve the park site with the cooperation of the Community Recreation Committee. Motion Carried.

Mr. Buckley reported that the Clifton Volunteer Fire Department has not approved renting the extra fire stall to the Clifton Post Office, but suggested thought should be given to provision of a better post office facility. Since one of the difficulties of locating new buildings on small town lots available is the lack of space for drainage fields, it was suggested that a study be made of a modified sewage system for such lots, and that Mr. Douglas Detwiler be contacted for his ideas. Mr. Detwiler suggested that a large filter might be advisable, and that the State Health Department should be contacted; in a previous installation their specification was approximately 35 sq.ft. per person to be accommodated by the common filter. Mr. Buckley was asked to look further into this matter.

Minutes of the previous meeting were read and approved.

The mayor introduced consideration of the question of appropriation of public funds in the nature of an advance of 1954-55 appropriation for fire protection to the Clifton Volunteer Fire Department to assist in the purchase of an ambulance to be used for community service, and invited comment from the audience. Mrs. Delsie Buckley was recognized and voiced her opposition to further appropriation to the CVFD on the basis that an aggregate of \$1450 has been appropriated over the lifetime of the group, including donation scheduled under present budget, and conviction that money should not be used which has been budgeted for other purposes, even though not so expended at this time. Also the fact that the County underwrites Fire Department.

Mr. R. Buckley explained that the opportunity for purchase arose unexpectedly, although the possibility had been discussed for some years, and that the Ladies Auxiliary had advanced the downpayment and pledged the balance of one-half the price. It was also explained that many of the expenses of the Fire Department are not defrayed by the County, including housing and maintenance, and certain items of equipment.

Mr. T. P. Fairfax spoke in favor of the expenditure, as did Mrs. Josephine Bryce, Mrs. Eleaner Taylor, Mrs. Lorena Selby, Mrs. White, Mrs. Dorothea Smith, Mr. Curran, Mrs. Millen, Mrs. Detwiler, Mrs. Helsley, Mrs. Elva Ambler, and other members of the Town Council, and Mr. Millen. #3 weather expressions of approal we appeal to a present the second of the Town Council.

Mr. McIntyre raised the question of whether this was in the nature of an advance. It was explained that it was. Mrs. McIntyre inquired how the ambulance would be manned. It was explained that training classes are being started and are open to all who wish to take them, and that women would man the ambulance in event of need, and are eligible for such duty. They signified approval of the plan.

Mr. Elmer Ayre and Mrs. Lillian Backley signified their approval of the ambulance service, but felt contributions should finance it. Mr. Basil Ambler and Mr. Wickliffe Buckley expressed the same feeling, and believed that use of tax funds for the purpose was not legal.

Mr. Buckley moved that the action of the Town Council of 30 April (appropriation of 300 dollars for Fire Department toward purchase of ambulance) be rescinded and the sum of \$350 be donated to the Clifton Volunteer Fire Department, taking into consideration the fact that the present Town Council will not be expending the balance of the Furniture and Contingent Funds as budgeted. Motion was seconded and carried, vote: Pro - Mr. Buckley, Mr. Detwiler, Mr. Fugett, Mrs. Sweeny; Con - Mrs. Buckley.

Following bills were presented and duly approved for payment, all members foting in favor:

Town Sergeant, April, sall& exp. \$10.00
Town Lighting, April 30.00
Trash collection, April 14.00

The mayor reported that the Health Department had come into Clifton and condemned 9 out of 10 outside toilets. Also condemned was one septic tank in the process of being installed. Copies of the new Fairfax County Sanitation Ordinance are being secured; these would have to be posted before adoption.

It was pointed out that the State Highway Department has cleaned ditches in Clifton. As yet they are unable to secure labor for sidewalk work; if Mr. Aichols is not able to secure labor soon, it may be necessary to locate an outside contractor for this work.

Mr. Fugett reported that it had not been possible to carry through on the proposed street clean-up on May Day, and it was suggested that this be done on 15 May if feasible. The matter was left to Mr. Fugett's discretion.

Mr. Buckley inquired whether check had been made as to possible conflict between the Town of Clifton Charter and newly passed law requiring candidates to file a minimum of 60 days before elections.

It was moved and seconded that the mayor be authorized to make arrangements with the same three judges for town elections, and if any of these are unable to serve, he be authorized to replace him. Motion carried.

It was moved and seconded that the mayor be authorized to have ballots reproduced for the election 8 June 1954. Motion carried.

The matter of speeding motorists within the town limits was raised by a member of the audience, and it was asked that something be done about this. It was explained that thought is being given to an ordinance to curb for this.

The problem of the dangerous ditch near the colored church was raised, and it was explained that the State Highway Department had been asked to place white posts around this place.

There being no further business to come before the meeting, it stood adjourned, at 10:30 p.m.

The courage and the vision of this few is now exemplified by a building that is the finest not only in Fairfax County but other counties as well. It is there to serve all in the community with a spacious meeting hall for all purposes-a lending library and most of all it isaugmented with the finest piece of fire equipment obtainable.

Now this same group have another vision by adding to it an ambulance, to serve the area on emergency call. Considering the price of this beautiful piece of equipment and with the low mileage --it's a windfall for Clifton--this of course probably is a secondary consideration. The most important is the benefits which can be given to a request where 6 moments count between LIFE and Death.

Those responsible for the procurement of this ambulance should be encouraged and the community as a whole stand behind them one hundred percent and under the circumstances I propose that there be no donations of any kind and in consideration of what this group have done that the Town of Clifton purchase the ambulance for the full amount and present it to the fire departemnt....

The facts are briefly these. The sale price of this ambulance, fully equipped except for sheets and blankets, is \$1250. The Ladies Auxiliary of the CVFD has voted to underwrite \$625 of this amount, and has advanced the downpayment of \$300.00. The Fire Department itself has been offered private backing for the balance of the cost, but would prefer to finance it from funds on hand, to be replaced by an advance on the amount customarily donated for community fire protection out of Corporation income.

The fact that the equipment is needed is beyond question. In fact it was first put to use today, when it was used to move an invalid home at a time when the Centreville ambulance was out on a protracted accident call. It is planned to man the vehicle with the regular Fire Department drivers and to obtain further first aid personnel through training classes to be held by the American National Red Cross. (These classes will be open to anyone desiring to attend.) The ambulance will also play a part in the Civilian Defense set-up, and will be equipped by CD with two-way radio. Services will be free to any who need them. Those who obtain reimbursement from hospitalization policies will be asked to contribute such payment to gas and oil funds. It will be operated strictly as a community/vicinity public service.

The clerk read the telegram dispatched to the Governor's Commission on Public Education in answer to letter soliciting opinion re segregated schools.

Letter from Mr. Kilbey was read by the clerk; Mr. Kilbey returned the check for dumping contract in view of the fact that it was proposed to sell the property. It was suggested that the Kown Council have this lot bulldosed to cover trash dumped outside the proper dumping maxum ground through a misunderstanding. It was moved and seconded that the Mayor be authorized to get a bulldoser to effect this clean-up. Motion carried. It was further suggested that Harry Sutphin might be able to do this work at low cost.

Mr. Manual Huntzberger was reported as having a suitable dumping ground, and being agreeable to executing a contract with the Town Council on the same terms as the previous one with Mr. Kilbey, provided trucks were not allowed to tear up the ground dumping in wet weather. It was moved and seconded that this proposal be accepted. Motion carried. The treasurer will cancel voucher and check to Mr. Kilbey and issue another to Mr. Huntzberger.

After some discussion of his proposal for surveying the town, it was moved and seconded that the outside boundary of the Town of Clifton be surveyed by R. J. Ratcliff, and that he be authorized to place necessary markers along this boundary and at the centerline. Metion carried. It was suggested that a further street survey and plat be completed at a later date as it became economically feasible; this action is mandatory under the state code (copy of extract attached hereto).

The mayor reported that the Resident Engineer had been contacted about placing of street signs, but final approval had not yet been received.

It was suggested that the street lighting fuse bexes be moved into the fire house, so that they could not be tampered with and changes could be effected more easily. Several new light poles are needed at thes time, and Mr. Detwiler was asked to look into the cost of both changes; in view of the fact that the lighting equipment is owned by the Prince William Cooperative, it is believed neither will cost the Town of Clifton anything.

Treasurers report is appended hereto. It was noted that expenditure for Special Halloween Police was greater than usual due to the fact that this holiday feel on Sunday, and it was necessary to maintain the force for three days.



Gentlemen:

At the regular November meeting of the Town Council of Clifton, Virginia, held at the Town Council Chambers on 5 November 1954, the following resolution was passed by unanimous vote, all of the members being present:

"BE IT HEREBY RESOLVED:

"THAT the Town of Clifton register its protest against the recent untimely action of the Fairfax County Board of Supervisors announcing its approval of immediate action to end segregation in the public schools of Fairfax County in advance of pending policy decisions by the United States Supreme Court and by the Governor of the State of Virginia on this matter; and further

"THAT the said Fairfax County Board of Supervisors be respectfully petitioned to withdraw the aforesaid asnouncement and action, and to delay any further action on the matter until after the Governor of Virginia's Commission on Public Education has held public hearing of the views of the citizens of the State of Virginia and made its formal report of findings on the commensus of public opinion in formal report and the Governor of Virginia has further issued a formal statement of policy on the matter; and further

"THAT no public statement of policy of any kind be made on behalf of the County of Fairfax unless and until all citizens of that county have been given the opportunity to voice their opinion on both policy and means of resolving this question in the light of the pending policy announcements of the Supreme Court of the United States and of the Governor of the Statemof Virginia."
