



**CLIFTON TOWN MEETING MINUTES
TUESDAY, June 30, 2010 7:30 PM**

Town Council members present: Wayne Nickum, Tom Peterson, Chuck Rusnak, Deborah Dillard, Mike Anton, Pat Layden

Town Officials present: Kathleen Barton, Clerk, Marilyn Barton, Treasurer

Tom Peterson called the special meeting to order at 7:40pm. He wanted to thank the town council for all their work – Deborah Dillard, for the work she did on the Community Hall; Chuck Rusnak, for the website; Mike Anton was extremely helpful to Mr. Peterson during town meetings, he knew all the meeting procedures; Wayne Nickum, who has the knowledge and resources, and if something is needed, he knows where to find it; Pat Layden, for his work on major projects: the bridge, the Old Town Hall, the Pink House, etc, they were all successful because of the time he put in.

The topic of today's meeting is the budget. First, he wished to add one agenda item: the discussion on Clifton Elementary, and a proposal: he would like to present to start the process to designate that school as a national structure—the town has documentation that because of its proximity to town, this is something that could be done.

Motion: Wayne Nickum made a motion to set this proposal in motion. Pat Layden seconded the motion, and it was unanimously approved.

It was a unanimous vote to add this to discussion. Concerning the budget, Wayne Nickum only made one comment, that he received a letter dated June 23, 2010; he also added that the town applied for additional funding. The funds would not be available until October 1, 2010.

Motion: Wayne Nickum made a motion to approve the budget. Pat Layden seconded the motion, and it was unanimously approved.

Concerning the porch roof, there should be no reason to hold off. It is proposed that the date by set for perhaps no later than the 26th of July to begin work on it. The project itself will take about a week and a half.

Motion: Pat Layden made a motion to begin work on the Pink House porch after July 1st. Wayne Nickum seconded the motion, and it was unanimously approved.

Clifton Elementary-

Tom Peterson stated that Bill Holloway has been actively involved, and it has been a long, uphill battle, looking for a way to always help the cause, even long shots. One very qualified woman, who lives past Clifton Elementary has gotten numerous letters that stating that because of proximity of the school to the historical town, that they think the town would get the school designated as a historic property very quickly. The town needs to start the process.

Motion: Tom Peterson made a motion that the Town start the process of having Clifton Elementary school be designated as a historic property, as well as asking Fairfax County to prepare the application for the town of Clifton with the signature of the mayor. Deborah Dillard seconded the motion, and it was unanimously approved.

Motion: Mike Anton made a motion to adjourn. Pat Layden seconded the motion, and it was unanimously approved.
