TO RESIDENTS OF CLIFTON:

You have probably read in the paper recently that the Town Council has prohibited parking at any time on Pope's Head Read west of the Centreville Road; and that they have also prohibited all swimming or loitering along Pope's Head in that vicinity. This action was taken in response to several things - first, many and continued complaints from residents; second, police reparts; and third, the opinion expressed by the following letter from the Fairfax County Health Department. This letter is queted so that you may judge for yourself the serieus health situation and impress it on your children.

March 22, 1962

Dear Mayor Elgin:

Re: Swimming in Pope 's Head Creek

In reply to your resent request to Mr. F. P. Johnson of this department, in regards to the above subject we wish to advise as follows:

The only waters approved as safe for swimming by this department in Fairfax County are the waters of artificial swimming pools, equipped with an approved filter system and constructed in accordance with the requirements of the Pairfax County Swamning Peol Ordinance.

There are several septic tank sandfilter systems that discharge treated effluent in the waters of Pope's Head Creek in the Town of Clifton. These discharges add to the natural pollution of Pope's Head Creek in the Town of Clifton.

If there is and additional information we may furnish you on this matter please advise.
